Clinic registration expires June 30<sup>th</sup> 2023. The fee for renewal is set at \$100 for the registration period July 1<sup>st</sup> 2023 to June 30<sup>th</sup> 2024. Please complete all sections of the attached renewal form and send to the College at the address above.

#### 1. NAME OF CLINIC:

Enter the name, address and current mailing address for the clinic, Telephone, fax or e-mail information. Clinic registration numbers may be found on the College receipt.

# 2. TYPE OF BUSINESS: Tick the type of business.

Incorporated clinics should have current certification. Attach current Certificate of Good Standing. Current incorporation certificates may be obtained from the Registry of Companies.

#### 3. CONTACT INFORMATION:

The principle contact is the person who the College may contact regarding clinic registration.

#### 4. SHAREHOLDERS:

Please list current shareholders.

# 5. DIRECTORS:

Please list current directors.

#### 6. OFFICERS:

Please list officers.

#### 7. PHYSIOTHERAPISTS:

#### List all physiotherapists currently providing physiotherapy to clients.

List physiotherapists currently employed and their registration numbers. Indicate whether they are employed as an employee or as a contractor, either Full or Part time.

#### 8. PHYSIOTHERAPY SUPPORT STAFF:

List support staff involved in the delivery of physiotherapy services, their job titles, and the role they fulfil in physiotherapy delivery.
